LWVPFA Voters Services co-chair Claudette Hall, with a help of the committee, was very busy registering voters in the south suburbs prior to the primary election. Pat Cline has assisted with all the drives; Sandra Warren, Jerry Bridges, and Jackie Parker (new League members who have joined the committee) have helped too.

Voter registration drives were held at Marion, Crete-Monee, Bloom Trail, Rich East, and Rich Central High Schools. Over 100 new voters were registered.

The committee also helped plan and run the candidates forums which were held in January in conjunction with the Leagues of the Homewood-Flossmoor Area and the Palos-Orland Area. Forums were held for candidates for both the 5th and 6th districts of the Cook County Board. Both forums were very well attended and quite lively! WHAT IS PROGRAM PLANNING?

The Program Planning process is the League tool for identifying issues for study and is the process for making recommendations concerning program issues –This is how League remains a grassroots organization!

PROGRAM is a three part process composed of program planning, study and consensus, and advocacy. Program is the League term for positions on issues and this is our opportunity to affect the topics studied and the positions reached which lead to action on the position.

What is the purpose of the Park Forest Area meeting? To provide input on issues that members believe need to be studied or action taken. This is our opportunity to discuss our concerns on issues and have a voice in the activities of the LWV. The League is gathering input from local leagues throughout the country. It also is an opportunity to identify LOCAL issues which should be studied.

What will we do at this planning session? We will discuss the LWVUS positions on the national issues and evaluate the need for retaining or restudying any specific position. This process is the initial grassroots step leagues take in preparation for discussion and decision-making at the LWVUS convention in June. Each local League will report its decisions to the LWVUS Board who will decide which issues/positions will be recommended for study or action in 2010-2011.

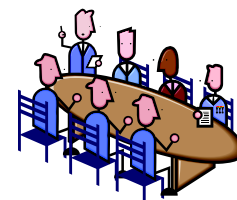
Observer Reports on LWVPFA.ORG *by Barbara Sturges*

Learn about the Illinois Fair Map Amendment – Why We Need It and How We Can Help! *By Sharon A. McGuire*

On Sunday March 7, 2010, at 3 pm, Jan Czarnik, Executive Director of the League of Women Voters of Illinois will present information on the need for a new process for drawing the boundaries of legislative districts in Illinois. As you'll read elsewhere in this Intercom, the League of Women Voters of Illinois is in the forefront of the effort to make this change!

As members of the League of Women Voters we are aware of the flawed, political system legislators currently use to draw district lines – with decisions made to protect incumbents, without true competition. **The League of Women Voters Illinois needs your help** to change this process and take it from the legislators and put it in the hands of an independent commission in order to make redistricting more transparent, fair, and accessible to the public. In order to do this, **by April 1, 2010 500,000 signatures are needed** on petitions to get the amendment on the November ballot. The League is looking for all of us to do our share to make sure we have those needed signatures. Please visit www.ilfairmap.com to download petitions and directions for completing them. LWVIL Phonathon *by Sharon A. McGuire*

Our League will participate in this year's Phonathon. We will meet at the University Park Golf and Conference on Friday, March 19th at 5:00 PM. I have asked for eighty names to call, so if we have eight members to agree to call 10 donors, this project should not take long to complete. The following is the *Local League Phonathon Sharing Policy* from the State:

"If your local League participates in making calls for the annual LWVIL Phonathon (scheduled from March 1—April 9, 2010), any gifts mailed to the state League office by your local members prior to May 1, 2010 will be counted toward the total gifts on which your share is based. **Sharing percentage is 15%**. In addition, your League will receive 15% of donations received (not pledges) in response to calls made by your League members to other members whose Leagues are not participating in Phonathon. Phonathon pledge payments will be tallied on June 26, 2010 to determine each participating local League's total. League members making Phonathon calls from home will be reimbursed for any long distance expenses incurred: no reimbursement is made for local calls. Documentation is required to receive reimbursement (copy of phone bill with Phonathon long distance calls clearly marked)."

This year the National Convention will be held June 11—15, 2010 in Atlanta, Georgia.
